- 7) N.S.F. cheques will be subject to a \$40.00 charge.

- 8) Failure to comply with these Terms and Conditions may result in cancellation of credit privileges without notice. In the event of any default A.A. Access Equipment Ltd. May (a) close the account and/or (b) accelerate payment of the full balance.
